# Alabama Public Charter School Commission February 4, 2019 9: 30 A.M. Face to Face and Teleconference

### **MINUTES**

### Welcome, Approval of Minutes and Agenda

Mac Buttram opened the meeting by welcoming everyone. He asked for a roll call of the Alabama Charter School Commission (APCSC). He also introduced David Marshall, the new Commissioner. The minutes and the agenda were both approved by a unanimous vote.

## **Future Enrollment Projections**

Mac Buttram introduced Mr. Jeremiah Newell from Acceleration Day and Evening Academy by teleconference to speak in regards to their request to amend the contract to include additional grade levels. Commissioners discussed the pros and cons to adding to the enrollment. Mr. Tommy Ledbetter made the motion to approve the request, and Mrs. Lisa Williams seconded the motion. The vote was unanimous to approve. Chairman Mac Buttram introduced Dr. JJ Wedgworth by teleconference to speak in regards to University Charter School's request for expansion. Mrs. Lisa Williams made the motion to approve the request and Mr. Henry Nelson seconded the request. The vote to approve was unanimous.

# **Presentation of Rosa J Young Academy**

Mac Buttram introduced representatives of the proposed Rosa J Young Academy to be located in Selma Alabama. They made a presentation of the proposed school. A question and answer period followed the proposed application. The motion was made by Mr. Henry Nelson to not approve the Rosa J Young proposed application. Mrs. Lisa Williams seconded the motion. The vote was unanimous to not approve the application.

# **Presentation of Capstone Charter School**

Mac Buttram introduced representatives of Capstone Charter School to be located in Tuscaloosa, Alabama. Representatives made a presentation with a question and answer period that followed. Mac Buttram asked the applicants to explain why they were not a private school, and a discussion followed. Mr. Henry Nelson made the motion to approve the application, and Mrs. Lisa Williams seconded the motion. It passed six in favor, one abstention, and one opposed. Mr. Charles Jackson abstained, and Mr. Ibrahim Lee voted no to the approval.

#### **Executive Session**

Mr. Henry Nelson made the motion to go into executive session during lunch to discuss the legal ramifications and legal options for pending litigation and to discuss legal ramifications and legal options for controversies not yet litigated but immediately likely to be litigated if governmental body pursues a proposed course of action. The meeting will reconvene in one hour. The motion was seconded by Mrs. Lisa Williams. The vote was unanimous.

# **Appeal by I3 Academy**

Mac Buttram read the letter by applicants for I 3 Academy. Mrs. Lisa Williams made the motion to hear the appeal. Mr. Henry Nelson seconded the motion. The vote was unanimous to hear the appeal at the next meeting.

### **Auburn Center of Evaluation**

Mac Buttram introduced the need to approve an external reviewer for the application. Mac Buttram asked for a motion to approve to the Auburn Center of Evaluation (ACE). A discussion followed. Mr. Tommy Ledbetter made the motion to approve ACE, and Mr. Ibrahim Lee seconded the motion. The vote was seven in favor and one absention by David Marshall due to a work relationship.

# **Appeal by Lead Academy**

Mac Buttram read the letter requesting an appeal by applicants for Lead Academy. Mr. Tommy Ledbetter made the motion to hear the appeal including a review by ACE, and Mrs. Lisa Williams seconded the motion. The motion to hear the appeal and to have a review was unanimous.

## **Motion to Adjourn**

Mac Buttram asked for a motion for adjournment. The motion was made by Mr. Henry Nelson, and Mrs. Lisa Williams seconded the motion. The meeting was adjourned.
